The baby bar is another name for the First-Year Law Students' Examination (FYLSE). It is administered by the State Bar of California in both June and October each year. Not everyone has to take the baby bar exam! It is primarily administered to those who study law at unaccredited law schools (including online law schools).

The Baby Bar Exam (FYLSE) Requires at least 4-5 months of Preparation. To pass the Baby Bar Exam (FYLSE) you must start preparation almost 4-5 months in advance. You will need to write 150 full essays of 50 each in Torts, Contracts, and Criminal law. You will need to do 3,000 questions and answers and as an added kick you should memorize the sample tests that the California State Bar sells of old prior multiple choice exams.

California Baby Bar Exam Overview. The First-Year Law Students' Exam is administered in the Los Angeles and San Francisco areas in June and October each year.
